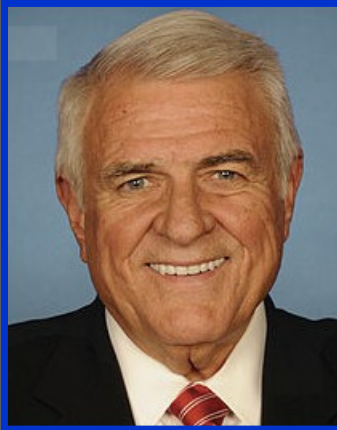

JOHN CARTER

JOHN RICE CARTER* is the U.S. Representative for Texas 31st congressional district, serving since 2003 and elected Secretary of the House Republican Conference on November 17, 2006.

Carter graduated from Texas Tech University with a degree in history and earned a law degree from the University of Texas School of Law. After a successful private law practice in Round Rock, he was appointed as judge of the 277th District Court of Williamson County and was reelected four times. Carter retired from the bench in 2001 in order to run for Congress in the newly created 31st District. He has been reelected twice.

A staunch fiscal and social conservative, Carter is best known as the author of a law that made it easier to prove identity theft and provides stiff penalties for the offense.

Carter is also a proponent of the "Rangel Rule," where IRS penalties and interest would be eliminated if one paid back taxes, similar to the treatment Rangel, Treasury Secretary Timothy Geithner, and former South Dakota Senator Tom Daschle received after their tax problems were made public.

Carter wanted Rangel to step down from his position and continued to demand that Democrats comply by their promises made in 2006 of running the "most ethical Congress in history" and to "**drain the swamp.**"

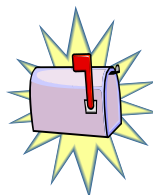
Carter has had many committee assignments and party leadership and caucus memberships in his career.

He and his wife, Erika, of almost 40 years have four grown children. They have lived in Round Rock since 1971.

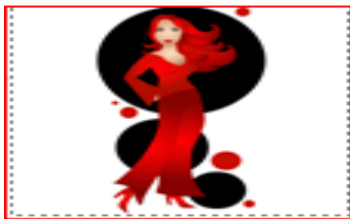

LEGISLATIVE

“If there is no struggle, then there is no progress. FEDERAL: After a lengthy battle, Congress will decide this fall whether or not to extend the tax relief laws currently in force or significantly raise personal income taxes. President Obama has proposed several changes to tax law in his 2011 fiscal budget that raise taxes on those who earn more than \$250,000. This would directly impact businesses, including small businesses who are the primary job creators in this country. The jobs bill offered by the White House will cost \$250,000 for every job created or saved. A significant change was made by the President to the U.S. Education policy when he used executive authority to give states more flexibility to opt out of some provisions of the “No Child Left Behind” program that was enacted by President G.W. Bush. Most states are expected to apply for the waiver. This would give them more control over how they deal with troubled schools. The President states that the waiver would not lower standards, but would raise them because to get the waiver, the standards would have to be raised. The current law is said to negatively encourage the lowering of standards in order for a school to reach its mandated goals.

STATE: Ten proposed amendments to the Texas Constitution will be voted on at the November 8th election polls. CAMPAIGN UPDATE: With Senator Ogden's recent announcement that he will not run for another term, two key changes have occurred that will impact District #20: 1) Rep. Schwertner will run for Senator Ogden's open seat, and 2) State Board of Education member Marsha Farney and Jeff Fleece, Vice-Chair of Travis County Republican Party, have both tossed their hats into the ring for the Texas House District #20 seat. There is never a dull moment in politics!

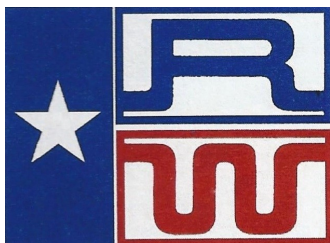
