Be It Resolved that the Texas Legislature must: ban all vaccine mandates by all public and private entities; prevent Texas employers from hiring, promoting, or firing workers or volunteers based solely on vaccination status; prohibit students of any age or field of study from being denied educational opportunities based on vaccination status; prohibit the denial of any public service or benefit based on vaccination status; prohibit the denial of emergency or life-saving medical care based on vaccination status; reject any attempts to mandate, force, or coerce any medical test, procedure, or product, including vaccines or masks, on Texans; and preserve the statutorily protected right of Texans to utilize the Texas Exemption from Immunizations for Reasons of Conscience Affidavit without scrutiny or adverse action. Resolution Title 12. Detransitioners' Bill of Rights

Whereas Statements (Not Required)

Be It Resolved that the Republican Party of Williamson County recommends the Platform Committee of the Senate District Convention adopt as a Platform Plank the support for legislation establishing a Detransitioners' Bill of Rights.

"A. The state has compelling interest in protecting the health and safety of its citizens, especially vulnerable children and adolescents.

B. Recent years have seen a rising number of individuals known as detransitioners who were initially subjected to physiological interventions to alter their appearance and bodily functions to align with their perceived sex or perceived gender but who later experienced a resolution of any inconsistency between their sex and their perceived gender or perceived sex.

C. There is a concerning lack of treatment guidelines for the medical care of detransitioners. Detransitioners report a dearth of information about ceasing hormonal treatments and frequently encounter clinicians who are poorly informed about medical detransition. In addition, some jurisdictions have mandated insurance coverage for gender transition procedures but have refused to extend this mandate to detransition procedures.

D. Detransitioners have a right to transparency from their medical providers, effective medical care, and legal restoration."
